

An Acc^t how George Goring Esq. of Ardes derives his Pedigree from S. W. Goring K. to whom King Edw. the 6. granted the Mannors of Balnethorpe. and to the Heirs Male of his Body. And how he now claims the said Estate (on the death of S. W. Goring Bart. lately deceased) by virtue of that Entayle.

Note — The said S. W. Goring (the common Ancestor) dyed on or about the year 1553 leaving Henry Goring his Eldest Son and Heir who dyed about the year 1594 leaving Issue two sons viz. W. Goring and Edward Goring.

N.B. — S. Harry Goring of Highdean Bart. puts in his Claim to the same Estate as a Descentant from the said Edw. Goring who was youngest Son of the aforesaid Henry.

The Pedigree and Title

W. Goring (Eldest Son and Heir of Henry Goring Esq.) was Married about the 24. of January 1563 to Anne the Daughter of Robert Durbage by whom he had Issue — S. Henry Goring his Son and Heir, Baptized about the 23. of August 1573 And the said W. (on the death of the said Anne) remarried with Margaret the Daughter of Richard Challoner by whom he left Issue One Son named George.

Note — This S. Henry Goring was Great Grandfather to the last S. W. Goring.

The said George Goring Married Catharine the Daughter of Richard Cheyney Esq. and left Issue 4 Sons viz. George, Edward, Thomas, and John.

Vide. Chart 3. Octo: 44. Eliz being a Settlement made on the said George Goring & Catharine his wife of several Lands in Barcombe, Hamsey and Newick. And made between Henry Goring of Barton Esq. (son and Heir of W. Goring late of Barton Esq. deceased) and Eleanor his wife the said George Goring (Brother to the said Henry Goring and 2. Son of the said W. Goring) and Catharine his wife. Daughter of Richard Cheyney late of Crawley Esq. deceased and others.

George (Eldest Son of the aforesaid George) dyed without Issue.

Edward the 2. Son dyed also without Issue.

Thomas the 3. Son dyed without Issue.

John the 4. Son Married Eleanor the Daughter of Garret and left Issue 2 Sons viz. George and Edward.

George was Baptized about the 5. Feb. 1645 and Married 2 Wives viz. the first was Eliz. the Daughter of M. John Newnham by whom he left Issue One Son named George who is by Gentleman as now claims the Balneth Estate as next Heir Male to of the said S. W. Goring.

The aforesaid George Goring's 2. wife was Elizabeth the Daughter of M. Mill by whom he left Issue One Son named John now living at Barcombe.

Edward Goring youngest Son of the aforesaid John Goring was Baptized about the year 1657 but dyed without Issue.

N. B. — The aforesaid Thomas Goring by his last Will and Testament dated about the 8. of June 1667. Did Give and Devise the Mannor of Barcombe pr. To the aforesaid George Goring his Nephew Eldest Son of the aforesaid John Goring his Brother.

A List of the persons Names who have been Lords of the Mannor
of Darcombe for 185 Years and upwards.

St Nicholas Carew was Lord thereof the 10. April 29. King H: 8. and so continued till after the
22. Oct. 30 H: 8.

The said H: 8. was Lord thereof and held a Court the 23. April 30. year of his Reign: The said
Mannor being forfeited to him on the s. d. Nicholas Carew being Attainted of High Treason.

Elix: Carew Widow of the s. St. Nicholas (the s. King H: 8. having regranted the s. Mannor back again)
and held Courts there from the 10. Sept. 31. year of the Reign of H: 8. to the 26. April 32. H: 8.

Francis Carew was Lord thereof from that time till after the 22. Oct. the 2. year of the Reign of H: 6.

After w. the s. Mannor came to George Goring 2, son of the first S. W. Goring who held a Court there from
the 7. March 1572. till the 9. April 1579.

William Goring Nephew to the s. George Goring was Lord thereof from 20. April 1582 to 10. Jan. 1594.

After w. George Goring 2 son of w. Goring was Lord thereof from 16. July 1640 to 4. July 1651.

Edw. Goring 2, son of the s. George was Lord thereof from the 5. Sept. 1653. to the 26. Oct. 1658.

Thomas Goring 3, son of the s. George was Lord thereof from 18. April 1664 to the 13. Oct. 1668.

George Goring Nephew of the s. Tho: and East Son of John Goring 4. Son of the 1. George Goring
was Lord thereof from the 24. March 1669 to the 14. July 1714.

And from thence to George Goring East Son of the last George Goring (by Elix: Rownham his 1. wife)
who is now living and Lord of the said Mannor.
